#### 4. First aid measures

**EYES:** Irrigate copiously with clean, fresh water for at least 15 minutes. Seek medical advice.

**SKIN:** Wash immediately with plenty of water. Remove contaminated clothing. If irritation persists, seek medical attention. Wash contaminated clothing before using them again.

**INHALATION:** Remove to open air. If breathing is irregular, seek medical advice.

**INGESTION:** Obtain immediate medical attention. Induce vomiting only if indicated by the doctor. Never give anything by mouth to an unconscious person.

#### 5. Fire-fighting measures

##### GENERAL INFORMATION

Use jets of water to cool the containers to prevent product decomposition and the development of substances potentially hazardous for health. Excess pressure may form in containers exposed to fire at a risk of explosion. Always wear full fire prevention gear. Collect extinguishing water to prevent it from draining into the sewer system. Dispose of contaminated water used for extinction and the remains of the fire according to applicable regulations.

##### SUITABLE EXTINGUISHING MEDIA

The extinction equipment to be used is the conventional kind: carbon dioxide, foam, powder and nebulised water.

#### 6. Accidental release measures

##### PERSONAL PRECAUTIONS

Eliminate all sources of ignition (cigarettes, flames, sparks, etc.) from the leakage site. If there are no contraindications, spray solid products with water to prevent the formation of dust. Use breathing equipment if fumes or powders are released into the air. Block the leakage if there is no hazard. Do not handle damaged containers or the leaked product before donning appropriate protective gear. ##### ENVIRONMENTAL PRECAUTIONS

##### METHODS FOR CLEANING UP

#### 8.2 Exposure controls

As the use of adequate technical equipment must always take priority over personal protection equipment, make sure that the workplace is well aired through effective local aspiration or bad air vent. If such operations do not make it possible to keep the concentration of the product below the permitted workplace exposure thresholds a suitable respiratory tract protection must be used. ##### HAND PROTECTION

Protect hands with category II (ref. Directive 89/686/EEC and standard EN 374) work gloves, such as those in PVC, neoprene, nitril or equivalent. The following should be considered when choosing work glove material: degradation, breakage times and permeation. Work glove resistance to preparations should be checked before use, as it can be unpredictable. Gloves' limit depends on the duration of exposure.

##### EYE PROTECTION

##### SKIN PROTECTION

Wear category II professional long-sleeved overalls and safety footwear (ref. Directive 89/686/CEE and standard EN 344). Wash body with soap and water after removing overalls.

##### RESPIRATORY PROTECTION

If the threshold value for one or more of the substances present in the preparation for daily exposure in the workplace or to a fraction established by the company's prevention and protection service is exceeded, wear a mask with an A or universal filter, the class (1, 2 or 3) of which must be chosen according to the limit concentration of use (ref. standard EN 141).

The use of breathing protection equipment, such as masks with organic vapour and dust/mist cartridges, is necessary in the absence of technical measures limiting worker exposure. The protection provided by masks is in any case limited.

### 10. Stability and reactivity

The product is stable in normal conditions of use and storage. When heated or in the event of a fire, carbon oxides may be released and vapours which are dangerous to health. The vapours may also form explosive mixtures with the air.

Petroleum naphtha solvent: it can give flammable mixtures with air.

### 11. Toxicological information

Upon contact with skin, this product causes sensitization (dermatitis). Dermatitis derives from skin irritation on the areas which repeatedly come into contact with the sensitizing agent. Cutaneous lesions may include: erythemas, edemas, papules, vesicles, pustules, scurvies, ulcerations and exudative phenomena, whose intensity varies according to illness seriousness and affected areas.

Erythemas, edemas and exudative phenomena prevail during the acute phase. Scurfy skin, dryness, ulcerations and skin thickening prevail during the chronic phase.

The introduction of even small quantities of this liquid into the respiratory system in case of ingestion or vomit may cause bronchopneumonia and pulmonary edema.

This product may have a degreasing action on the skin, producing dryness and chapped skin after repeated exposure.

### 12. Ecological information

This product is dangerous for the environment and is toxic for aquatic organisms. In the long term, it may even have negative effects on aquatic environment.

Petroleum distillates, charcoal, vegetable extracts: they are mixtures of paraffinic, naphthenic, diterpenic and aromatic hydrocarbons.

Their behaviour on the environment depends on the concentration. In each case use, according to good working practices, avoiding disposal in the environment. As a rule, the product is poorly biodegradable.
