2. Hazards Identification

The product is not classified as hazardous pursuant to directives 67/548/EEC and 1999/45/EC and subsequent amendments and upgrades and does not contain substances classified as being hazardous to human health or the environment pursuant to 67/548/EEC and subsequent amendments.

3. Composition / Information on ingredients

4. First aid measures

6. Accidental release measures

PERSONAL PRECAUTIONS

Eliminate all sources of ignition (cigarettes, flames, sparks, etc.) from the leakage site. If there are no contraindications, spray solid products with water to prevent the formation of dust.
